#### AMENDMENT TO HOW CONDO DUES ARE CALCULATED APPROVED IN STRONG VOTE

Condo owners expressed an amazing sense of unity in passing an amendment to the Grandview Farm Condominium governing documents with 94 percent of those participating saying "yes."

Forty-eight unit owners cast votes, either in person or by depositing their ballots prior to the February 16 Annual Business Meeting. Forty-five of those ballots were in the affirmative.

The amendment under consideration dealt with the formula used to calculate monthly dues for owners of each of the four models in our complex (Yorktown, Townhouse, Lexington, and Monarch).

That original formula used the square footage of living space (all floors) to determine percentage of ownership in the condo and then on to percentage of financial responsibility for each in annual budget.

In proposing a change to that formula, the Condo Board took the position that the unit size has very little to do with the cost of operations, therefore it would be fairer to add an equal share of the common area to the square footage of the living space in making the calculation.

The resulting percentages decreased the monthly fees for Monarch owners and increased fees for Lexingtons, Townhouses, and Yorktowns.

Those fees will go into effect for the April billing and are as follows:

Monarch - \$310 Lexington - \$287 Townhouse - \$284 Yorktown - \$282

Unit owners who do monthly payments through their banking institution should make the necessary adjustments in the amounts in plenty of time for the April payment.
